**Agenda Item**: Review and Approval of Monthly Meeting (9/28/2011) Minutes.

**Conclusion:** Board Members approved minutes and they will be posted to the HOA website.

**Agenda Item:** Finalize contract for concrete / sidewalk repair.

**Discussion:** CAS to perform the work. Work should be done before really cold weather. Need to

take pictures of affected areas and mark sidewalk areas. Letter to affected homeowners

has been finalized.

Action Item(s): Dan and Hung to take pictures of and mark areas where sidewalks are in need of repair

– from tree roots or otherwise. Armstrong to send out the letters.

**Agenda Item:** Finalize snow removal contract.

**Discussion:** Reviewing proposals from VCI Inc. and Snow Removal Services in terms of cost; specifics

of proposals; equipment owned v. rented by providers; and previous townhouse

development experience.

Action Item(s): Jacinta to get a few questions answered by company reps. to help narrow down the

choice.

**Agenda Item**: Costco Expansion

**Discussion:** Jacinta attended 10/25/11 Planning Commission Meeting. The next meeting is

scheduled for 12/8/11. Costco indicated that they are working on proffer and asked about the letter that they would like from Windsor Mews. Jacinta indicated that we

would work on the letter as soon as status of proffer becomes clear.

**Agenda Item**: Review of Financial Reports

**Discussion**: Liens are being filed on delinquent dues. Need to consider an increase of HOA Dues in

order to meet budgetary requirements.

**Conclusion:** Will need to make a decision on dues soon to allow time for Armstrong to get the new

coupon books/mailings out to all homeowners.

**Agenda Item**: Budget 2012

**Discussion**: Need make a few adjustments to budget based on actuals from 2011.

**Conclusion:** Will take one more look at budget once changes are made.

**Agenda Item:** Door and shutter color chart – update.

**Discussion:** Cherlyn created a beautiful spread sheet of the entire neighborhood including elevation,

door and shutter colors. Need to establish which houses/elevations need shutters and what the color schemes need to be per the original Map of homes in Windsor Mews.

Action Item(s): Hung to look at Paint color compliance and whether certain houses should have

shutters. This step has been tabled until Spring.

**Agenda Item:** Shutters – replacing them.

**Discussion:** Have basic information re. shutter replacements. Need to format so information may

be placed on community website. Idea of FAQ section on website.

**Action Item(s):** Julie to format information on replacement shutters.

Agenda Item: Covenants Committee - walk-through for tree trimming, non-functioning post lamps,

weeds/trash pile up, etc.

**Discussion**: Lots of violations noted – an abundance of rotting wood on front of houses and garage

doors. Some homeowners will need a hearing due to non-compliance after multiple

notices.

**Action Item:** Need to address how hearings will be handled.

**Agenda Item:** Installation of "signs" -- update

**Discussion:** Cherlyn has new signs and will work on replacing faded signs. Also, there is a sign that is

leaning over by Entrance 3.

**Conclusion:** Cherlyn to take a look at leaning sign.

**Agenda Item**: Security / Locks for Tennis Court – update.

**Discussion**: Lock is needed for Tennis Court. Cherlyn may have found a new affordable locking

mechanism.

Action Item: If we end up resurfacing our tennis court, with Costco's help, we should take a look at a

new locking system.

**Agenda Item**: Neighborhood Watch Program – update.

**Discussion**: No update at this time.

Agenda Item: WM HOA Website update.

**Discussion**: Dan to take over the duty (previously handled by Ed Buhain) of posting updates to the

HOA website.

**Agenda Item**: Architectural Reviews & Resale Inspections.

**Discussion**: Per Hung, no inspections for now.
