#### **Minutes**

1. Review and approval of the minutes of the annual meeting held February 15, 2019

2. Address vacant board positions following election at the annual meeting

3. Roles and responsibilities of Board members for 2019

- 4. Resale inspections and architectural modification leads for 2019

Jacinta will be the Board member leading resale inspections and will reach out to Dan Shedd who has helped with them in the past. Jacinta and Jennifer will lead architectural modification reviews for 2019.

5. List and status of projects for 2019

Projects that were discussed include:

- Roadway resurfacing Dan Shedd continues to lead. RFP will be released following roadway core samples and engineering assessment thereof.
- Entrance light fixtures Jacinta continues to lead and assess for a permanent solution.
- Parking regulations and enforcement Tabled until after the roadway project.
- Tennis court surface cleaning Jacinta continues to lead and will follow up with vendor.
- Tot lot equipment inspection Dan Shedd will help with the cleanup and inspection this spring.
- Legal clarification on short-term rentals and other home businesses Jacinta continues to lead and is following up with the lawyer.
- 6. Landscaping jobs for 2019

A number of areas were discussed, including flowers at the entrances and mulch for the tot lot and walking path. Jacinta will coordinate a walkthrough with the landscaper to discuss other projects.

## 7. Covenants Committee lead and plan for the year

Shahin will be Covenants Committee lead for 2019. The Committee is planning to perform more frequent inspections for 2019, including more night inspections. In addition, an effort will be made to better standardize criteria for violations and clarify messaging to the owners.

### 8. Closure of covenants violations from 2018

Jacinta will perform follow-on inspections for those issues which were granted additional time to resolve at the end of last year. Those that are not resolved in time will begin to be fined in accordance with the dispute resolution process.

### 9. Social Committee Updates

Jennifer will organize a spring cleanup event to get the community involved in improving the appearance of the common areas.

Joe will continue to maintain and improve the website for 2019.

### 11. Newsletter and other communications
